47/17 POLICE REPORT – no reports received.

48/17 DRAFT NOTES OF LAST MEETING – Were signed as a true copy, to become minutes. Proposed Coun Stanley seconded Coun King.

49/17 MATTERS ARISING –

Speed Reactive Road Signs – LRPS will offer up to 6 passive sign as long as they are in agreement with the locations following the survey at a £40 cost. Reactive signs come at a cost of £1693 + £57 bracket. Agreed to have survey and put up passive signs initially. Churchyard trees, differing opinions from arborists, one advising pollarding, one crown reducing. Council not prepared to crown reduce due to costs.

Youths vandalising still. Generally pulling up shrubs and breaking trees. Looking into new Cobra cameras from Gordon Holstead.

Disappointed the Christmas Market was no longer to be held. Suggested initial grant monies should be returned to DIB. Agreed that as the Christmas Market committee were totally autonomous of the Parish Council nothing to discuss.
